1. The undersigned (hereinafter called Applicant) hereby applies for membership in and agrees that all electric energy will be purchased from the WHITE RIVER ELECTRIC ASSOCIATION, INC.
2. Applicant agrees to comply with and be bound by the Articles of Incorporation of Cooperative, the By-Laws of Cooperative and any amendments thereto, and such Rules and Regulations as may be adopted from time to time by Cooperative.
3. Applicant agrees, when service becomes available, that all electric energy will be purchased from Cooperative and will be paid therefor monthly at rates and service charges to be determined from time to time in accordance with the By-Laws of Cooperative.
4. Applicant agrees:
 - a. to make payment of such fee as designated in the By-Laws of Cooperative in respect to membership.
 - b. to make payment of such fee as is designated in the Rules and Regulations which are incidental to providing electric energy at the service connection.
 - c. that any fee specified in (a) or (b) shall be non-refundable except in the event this application is not accepted by the Board of Directors or the members, of if, for any reason, Cooperative cannot supply the electric service requested.
 - d. that upon request of the Cooperative based upon reasonable terms and conditions, to grant to the Cooperative one of more right-of-way easements for extending and furnishing service to the Applicant or any other Cooperative member or for any other need of the Cooperative in constructing, operating, and maintaining its electric system.
5. Applicant agrees to deposit with the cooperative such consumer's deposit as is required by the Rules and Regulations of Cooperative. Any portion of said deposit not applied to the payment of bills due Cooperative shall be refunded to Applicant upon termination of service.
6. The acceptance of this application by Cooperative shall:
 - a. Constitute a contract for electric service between Applicant and Cooperative which shall continue in force until canceled by at least ten days written notice by either party to the other.
 - b. Constitute an acceptance of Applicant to membership in Cooperative with such rights and liabilities as are specified in the By-Laws of Cooperative, provided however, that said membership shall terminate when Applicant ceases to purchase electric energy from Cooperative at the service connection designated herein.
7. Applicant, if he is accepted as a member of Cooperative, hereby authorizes Cooperative, upon termination of his membership in any manner, to transfer said membership to his successor in ownership or occupancy.
8. Applicant, by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of Cooperative, and it is expressly understood that under law his private property cannot be attached for any such debts or liabilities.

Information submitted on this application shall remain confidential except for White River Electric Association, Inc., business and operational related purposes. Member information will not be sold for advertising or other commercial purposes. Members shall provide WREA with updated and current contact information including phone number, mailing address and email. The undersigned member hereby agrees to the terms and conditions listed on the WREA membership card, WREA policies, applicable rate tariff, and By-Laws, as may be amended from time to time. In addition, in the case of default of payment or delinquent payment, the undersigned agrees to pay interest and collection fees (including attorney fees) along with the total balance. Exclusive venue and jurisdiction for collections shall be Rio Blanco County, Colorado.
