April is also White River Solar Renewal month. WREA mailed out renewal lease forms to members on April 1st and signed leases are due back to WREA by April 29, 2021. There is no need to mail in a check as renewal lease fees will be automatically applied to your May power bill. REFRIGERATORS

(Energy Star Rated) \$30/full size refrigerator \$60 additional for refrigerator recycling

CLOTHES WASHERS

(Energy Star Rated) \$30/top load clothes washer \$40/front load clothes washer

CLOTHES DRYERS

(Energy Star Rated) \$30/Energy Star dryer \$90/hybrid heat pump clothes dryer (ventless)

LED LIGHTING

\$8 per bulb/fixture or 50% of the bulb/fixture cost, whichever is less

500 lumens or greater Maximum of 50 lamps per year (Receipt is required)

FREEZERS

(Energy Star Rated) \$30/full size freezer \$60 additional for freezer recvcling

DISHWASHERS

(Energy Star Rated) \$20/dishwasher

ELECTRIC OUTDOOR EQUIPMENT

Electric Bike. Mower or Snow Blower: 25% of cost up to \$150

Electric Trimmer, Chainsaw, Pruner or Blower, Power Washers (18 volt min.): 25% of cost up to \$50

(UPC & receipt required maximum rebate is \$300 per member account)



RESISTANCE WATER HEATERS

(Energy Star Rated) \$30/standard unit (\$20/unit additional incentive for lifetime tank warranty)

\$350/unit - 30 gallon minimum air source heat pump water heater

ELECTRIC HEAT PUMPS

Air source:

\$300/ton for units rated from 15-17 SEER, \$450/ton for units greater than 17 SEER

\$100/unit additional incentive for central air source with integrated controlled ETS backup in lieu of a separate ETS incentive

\$85/unit for terminal units (through-the-wall mounted heat pumps)

Central ground source: \$500/ton

REBATES MUST **BE RECEIVED AND** PROCESSED WITHIN 120 DAYS OF PURCHASE.
